

**RESOLUTION OF THE HOUSING AUTHORITY OF THE CITY OF RAHWAY**

**RESOLUTION NO. 1491**

**DATE OF ADOPTION: June 11, 2015**

**SUBJECT: REAPPOINTMENT OF RAHWAY HOUSING AUTHORITY'S  
CURRENT FEE ACCOUNTANT, GENERAL COUNSEL AND  
AUDITOR**

**THE FOLLOWING RESOLUTION** was presented by the Executive Director/Secretary at a Regular Meeting held on June 11, 2015:

**WHEREAS**, the Rahway Housing Authority Board desires to appoint a qualified licensed Fee Accountant, General Counsel and Auditor; and

**WHEREAS**, the three professionals who currently serve the Board in these three positions have demonstrated their ability over the past year; and

**WHEREAS**, the three professionals have agreed to serve the Board in their current positions for another year at the same terms and conditions as last year; and

**WHEREAS**, since the Rahway Housing Authority procured these professional services through a public advertisement (RFP) for a one year term, the Procurement Laws of the State of New Jersey allows a one year contract to be extended for two 1 year periods or a total of 24 months under the same terms and conditions.

**NOW, THEREFORE, BE IT RESOLVED**, that the Rahway Housing Authority Board of Commissioners desire to reappoint the current Fee Accountant and General Counsel for one year at the same terms and conditions as they were procured during 2014's public RFP process. Annual Fees paid equally over a 12 month period:

Fee Accountant	$\$2,200 \times 12 = \$26,400$
General Counsel	$\$1,710 \times 12 = \$20,520$

**BE IT FURTHER RESOLVED** that the Rahway Housing Authority Board of Commissioners desires to reappoint the current Auditor for one year at the same terms and conditions as procured during 2014's public RFP process. The fee in the amount of \$11,460 will be paid in one lump sum when the audit is completed and submitted in a timely fashion to HUD.
